EDHEC Business School offers Summer Programmes based on its Nice Campus allowing participants to gain substantial learnings whilst enjoying the beauty of the French Riviera. The below information highlights a number of useful information prior to applying or arriving in France!



WHO CAN APPLY TO ATTEND AN EDHEC SUMMER PROGRAMME?

Graduate students from a partner university as well as free movers who comply with the minimum requirements.



HOW & WHEN DO I APPLY TO FOR A SUMMER PROGRAMME?

Limited places are available therefore students should fill in the EDHEC Summer Programme application file, and email

For those applying as an <u>exchange student</u>, please contact your home institution for full procedure and timeline.



MINIMUM REQUIREMENTS

The programme is open to Master students. Upper bachelor level students (Bachelor 3 or 4) with good academic results are eligible to apply. Students must be able to demonstrate proficiency in English equivalent to B2 level. For exchange students, a letter from the home institution certifying the student's proficiency will be accepted.



COST

- Service fees: €600
- Tuition fees: €2600 for free movers / Tuition fees waived for students nominated by EDHEC's partner universities to join the programme as part of the general exchange agreement. These students only pay the service fees.



CANCELLATION FEES & EXCLUSIONS

Travel costs to & from France, personal insurance, accommodation, personal expenses, books, passports & visas and anything not listed. Payment of the programme and service fees must be received to confirm registration to the summer programme. This will allow students to receive their letter of enrollment, accommodation contacts and any documents needed t obtain their visa.

ACCOMMODATION

Registered participants will receive a list of different types of accommodations available near the campus. Students may also find their own housing via dedicated platforms.



VISA

Students without a European union or EEA passport must have a visa to study within the summer programmes. EDHEC's international relations office provides all registered students with an enrollment letter.
