The University of Geneva, with Sustainable Finance Geneva and the Swiss Finance Institute, are pleased to announce the Geneva Summit on Sustainable Finance 2018 at the International Conference Centre Geneva (CICG) in Switzerland.

The theme for this year's event is "Emerging Trends in Sustainable Finance", providing a platform for sustainable finance related research relevant to academics, investment practitioners, think-tanks, policy-makers, nongovernmental organizations and civil society at large.

- The "E" and the "S": complements or substitutes?
- Sustainability in financial systems: stability and crises
- Finance and the sustainable development goals
- Technology and inequality
- Political instability, protectionism and social investments
- Natural capital risks and firm location
- Water related risks and opportunities for companies

BEST PAPER PRIZE: The GFRI will award the 2018 Best Conference Paper Prize (USD 1,500) to the best overall conference paper. Sustainable Finance Geneva will award the Innovation Prize for the paper with the most innovative ideas regarding research and products in sustainable finance (USD 1,000).

PAPER SELECTION: Submitted papers will be reviewed by the organization committee (Rajna Gibson Brandon, Philipp Krueger, and Jean Charles Rochet)

TRAVEL EXPENSES: Authors of accepted papers will receive travel grants to present their research in Geneva.
