"When Professor Watrin became the academic director of the Institute of Accounting and Taxation I became his first research assistant in May 2003. Exactly one year later, I had the chance to continue my research on audit regulation at the University of Southern California, USA sponsored by a stipend of the German Academic Exchange Service.

I finished my dissertation in November 2005 and returned to the Institute of Accounting and Taxation in June 2006 to continue my research in a post-doctoral position. Again, I was able leave the Institute to spend a semester at the London School of Economics in 2008.

After parental leaves in 2009 (Lukas) and 2011 (Hanna), I entered the academic job market to start to work in my current position as a Full Professor for International Accounting and Auditing at TU Dortmund University in May 2013. I am very proud that in 2017 two of my own Ph.D. students were able to finish their dissertations, and I hope that I was able to shape their academic path the way mine was guided by my academic supervisor. My family still lives in beautiful Münster where I like to play tennis or go running, but I am happy to exchange these sports in favor of a pink stroller again in March 2018..."

Dissertation of Fabian Riegler

Intangible assets have gained increased attention by tax planners in recent years. The mobility of this asset class opens up the possibility takeoff taking advantage of differential tax rate between countries. For example, a variety of countries allow for a reduced tax rate for gains from the utilization of intangibles (so called IP boxes).

In his dissertation, Fabian Riegler focuses on the benefits that can arise from a

transfer of intellectual property to a foreign subsidiary. The analysis particularly considers measures suggested by the BEPS action plan. The dissertation was graded with distinction ('summa cum laude').

For his outstanding dissertation, Fabian Riegler was awarded the Andreas Dombret Doctoral Thesis Award. The award honors dissertations that combine theoretical knowledge with specific applications in business or economic practice.

Circle of Excellence in Accounting and Taxation

The Circle of Excellence in Accounting and Taxation is the support and network program of the Institute of Accounting and Taxation. Young students with excellent academic qualifications, especially in the areas of accounting and taxation, can apply for this program. However, we also look beyond academic qualifications and seek a high level of integrity and goal-orientation. Currently, 35 undergraduate and graduate students participate in the program.

Like in previous years, the event schedule was manifold and combined social events and lectures. This year's (social) kick-off event was a **behind-the-scenes tour** of the student's cafeteria "Aasee". The cafeteria can host up to 1.600 students.
